To apply, all items from the check list following must be completed and relevant materials submitted in order for your proposal to be considered:

- No identifying name of an individual or school/center/program should appear on the front of any page. Doing so will result in disqualification
- The back of **EACH** page in the proposal should include:
 - ___ a. applicant name
 - ___ b. complete work address
 - ___ c. complete home address
 - ___ d. phone number(s)
 - ___ e. email address
 - ___ f. name of school/center/program
 - ___ g. work schedule – include days and times
- Maximum grant request is \$250.00; applications may be submitted for less
- Include applicant's CAEYC Membership Number
(Applicant must be a current member of CAEYC, but not a voting member of the CAEYC Board)
- Applicant is limited to one proposal per year
- Deadline for proposals is **Monday, October 19, 2009 submitted** thru US Postal Service
Entries postmarked after October 19, 2009 will not be considered
- Proposals should be typed, and include the following:
 - ___ a. brief description of school/center/program
 - ___ b. number of children served
 - ___ c. age ranges of children served
 - ___ d. plan of action briefly describing the following:
 - ___ i. how the funds will be used
 - ___ ii. time line involved
 - ___ iii. who will benefit and how
 - ___ e. itemized list (in list form) that includes:
 - ___ i. name of equipment to be purchased
 - ___ ii. manufacturer's info
 - ___ iii. cost of each item
 - ___ iv. total cost (including any taxes/shipping)
